After this, Jocelyn turned the meeting over to Brett Zbar, former chair, who introduced Rich Roberts, the new chair of the Alumni Fund Board of Directors.

Rich discussed his motivations for serving as an Alumni Fund volunteer, as well as what he is looking forward to as the chair of the board. He then thanked the staff, and recognized former chairs in attendance:

Rich discussed his objectives as chair, continuing the legacy of previous chairs. The objectives "running through the tape" as we near the end of the *For Humanity* Campaign, sustained Diversity, Equity, Inclusion and Belonging within the Board, as well as seeking to increase board member engagement. After this, he welcomed the new members of the Board.

Fiscal Year 2024 Results

Rich discussed the end results for Fiscal Year 2024:

- 2,360 volunteers made 45,000 solicitations
- 28,296 donors made 40,667 gifts
- \$40,007,467 in cash was received
- 30% of gifts were less than \$50
- The Executive Committee Challenge
 - o 150 donors made gifts totaling \$300,000
 - o 28 first-time or reactivated donors
 - o Alumni from 11 countries

He then celebrated some highlights from the year:

- Public Health, Environment, and Engineering Schools had record-breaking revenue years.
- 12 schools participated in a more robust Anniversary solicitation program which now includes a mail component. This concept was launched in the final quarter of FY24 and helped boost results in June. We look forward to this program providing a steady stream of revenue for our renewal efforts in FY25.
- The Nursing School's three-day campaign during Nurses Week (May) gave them a 1.3% boost to the overall participation rate during that time frame an incredible result.

Campaign Results

The Campaign has raised \$5.7 billion of the \$7 billion overall. The Alumni Fund specifically has raised \$273,984,000 of the \$350,000,000 goal. 276,777 gifts have been given. By June 30, we were ahead of our target on our straight-line projection. Our goal was \$262.5 million, and we reached nearly \$271 million.

FY25 Goals

Richard stressed the need to come back from the dip in FY24 and to meet the goals set for this year: \$45,000,000 cash raised from 31,000 donors, which includes more donor reactivation. Rich also discussed agent groups being restructured significantly to support the renewal of loyal donors and the reactivation of those who missed last year or the year before.

- o 6,000 alumni moved out of agent groups (long-lapsed donors, those with active pledges or recurring gifts)
- o 4,300 moved into agent groups Lybunts and 1 & 2 yr sybunts (gave in FY23 or FY22)

He further stressed the importance of everyone doing their part, reminding everyone that volunteer solicitations are the most successful. This having been concluded, Richard turned the meeting over to Tanya Rivero Warren.

Vice Chair's Remarks

After an introduction, Tanya Rivero Warren, Vice Chair, commented on why she is a volunteer, and why she accepted the role she is in. She further discussed her connections to both the YAA and the Board of Governors. Next, she discussed her perspective as a journalist covering the political discourse surrounding issues of college admissions and affirmative action and shared the demographics of the Yale classes of 2027 and 2028. She then discussed ways board members could be involved (list action items from slide), and then presented key dates for the Board members to be aware of.

Guest Speaker: Jim Levinsohn

Dean Jim Levinsohn of the Jackson School gave a presentation on the Jackson School as Yale's newest professional school, followed by a Q&A session.

Following questions from the attendees, Richard thanked Jim and adjourned the meeting.
