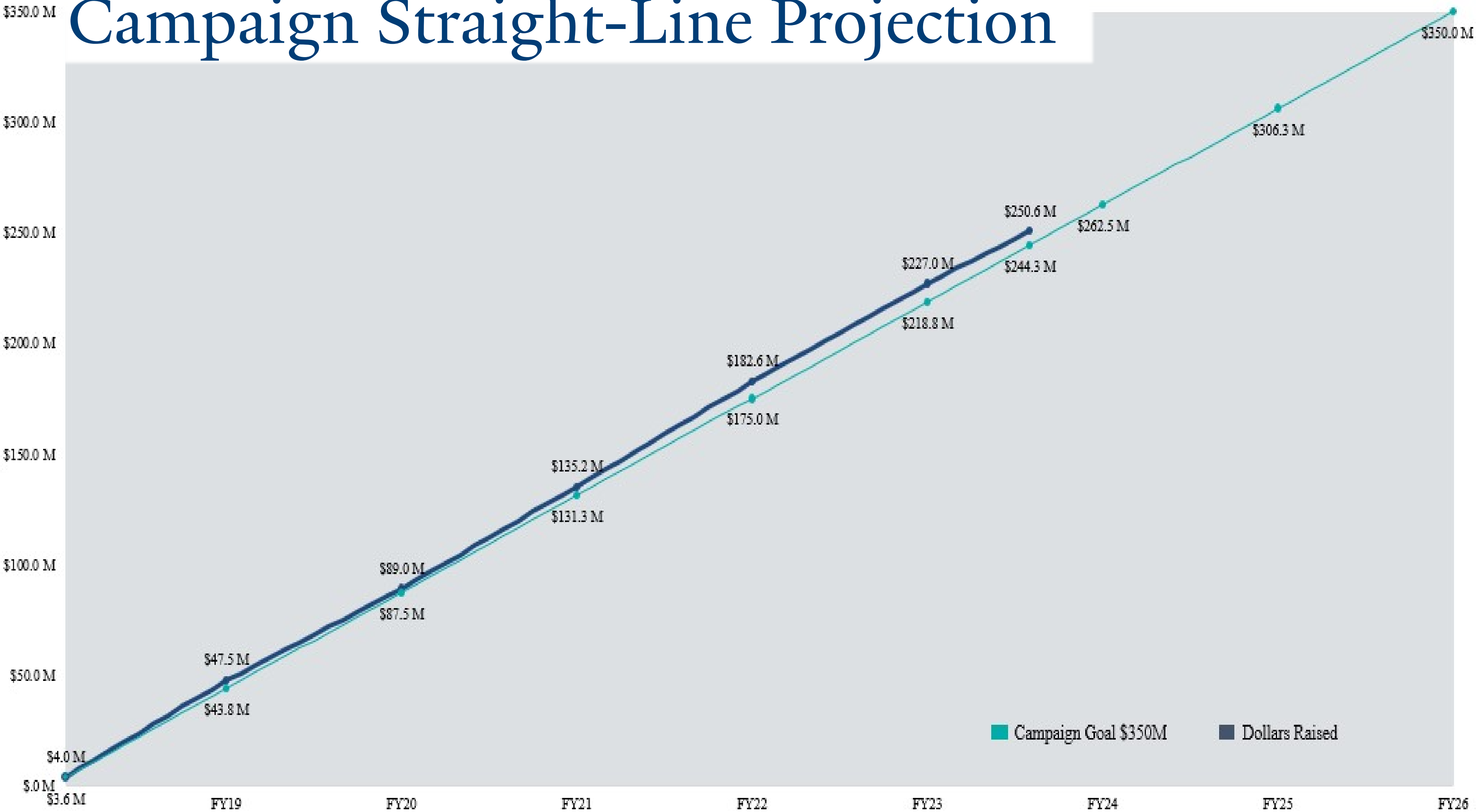

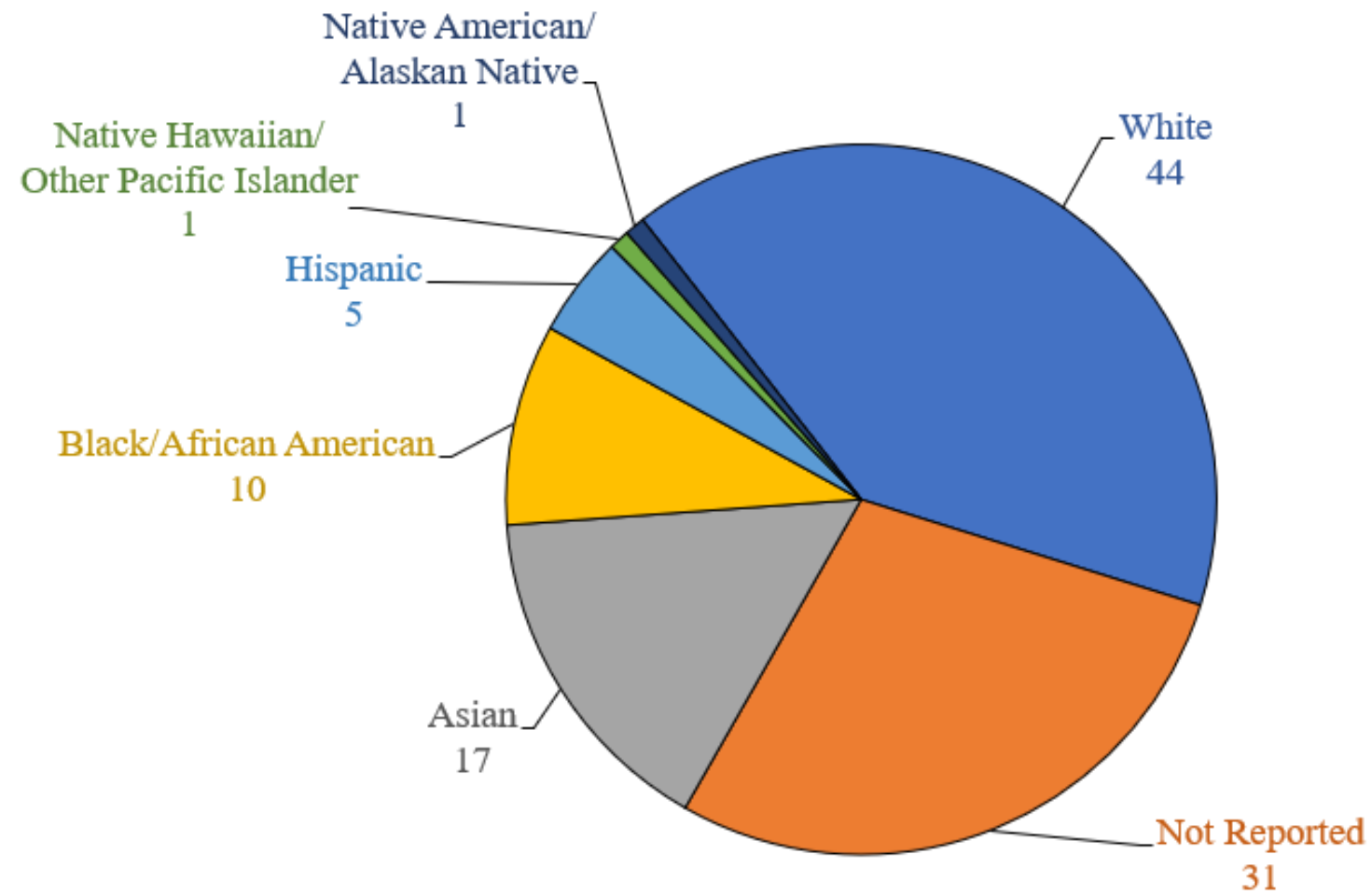
The Yale Alumni Fund Community:

- Leads with respect and tolerance. Expects all staff, volunteers and donors to treat people with respect and tolerance.

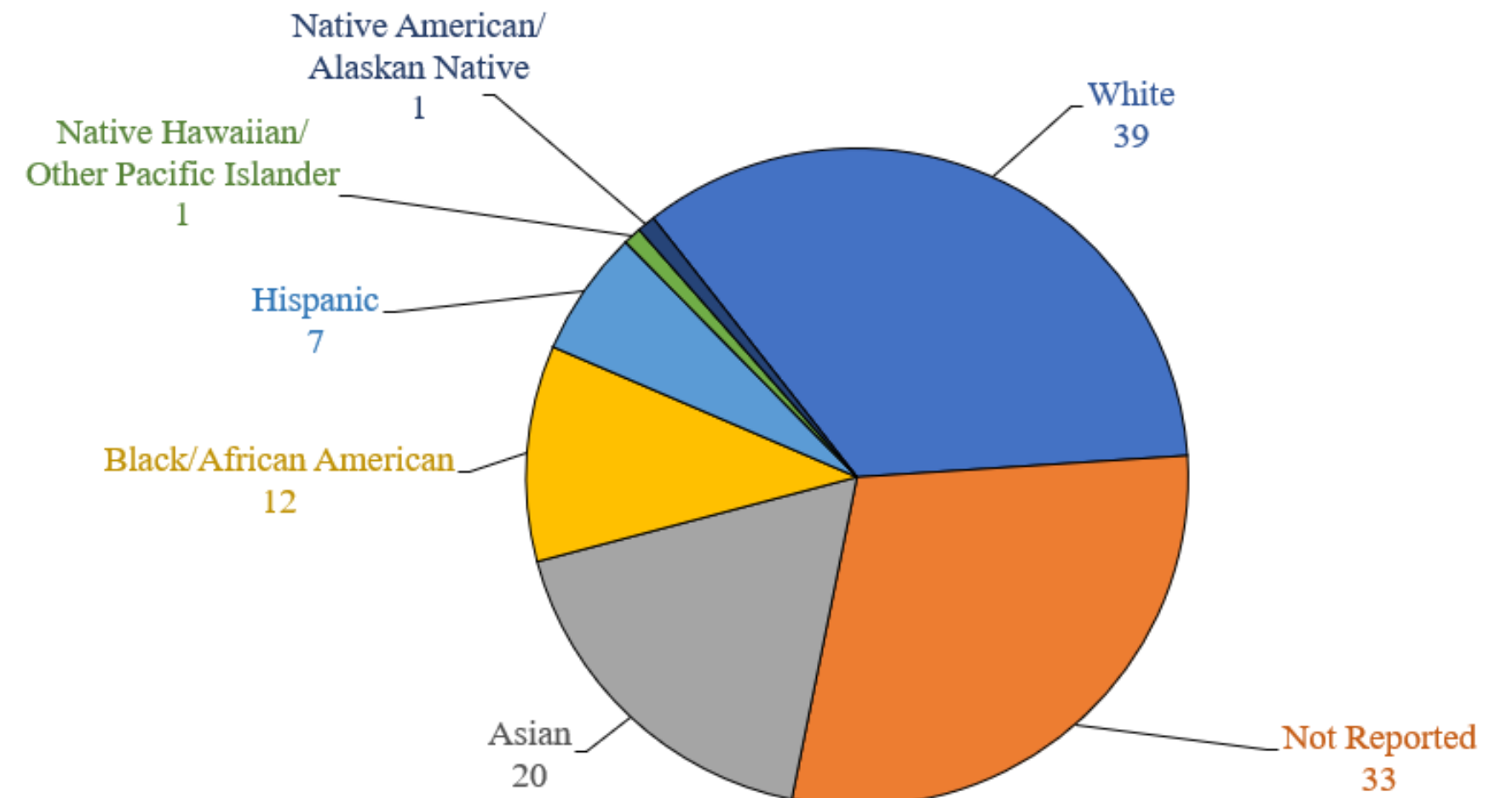
